Steve spent more than 32 years in "active" policing. The first half of his career was with the Washington County Sheriff's Department in Hillsboro, Oregon, where he worked assignments in patrol, dispatch, corrections, crime scene processing (CSI), detectives, planning and research, and as a contract administrator. He rose through the ranks to lieutenant while with the Sheriff's Department.

The second half of his career was with the Tualatin, Oregon, Police Department as Chief of Police. Steve was selected as Tualatin's first Police Chief, appointed to the position in 1987 when the City made the decision to form its own Police Department. The Police Department started with a sworn staff of 13, and had grown to 33 in 2003 when Steve retired.

During his time as Chief in Tualatin, Steve was active in the Oregon Association Chiefs of Police, and was elected President of the Association in 2000.

After leaving active policing Steve worked as a Risk Management Consultant, and he also taught criminal justice courses at Washington State University – Vancouver campus. For the past six years he has been working with the Oregon Department of Public Safety Standards and Training (DPSST) in a number of part time, interim, or full time positions; he has been the coordinator for the Leadership Development Program in Oregon for the past four years.

Steve holds a total of five college degrees, including a Masters Degree in Criminal Justice, a Masters of Public Administration, and he received his Ph.D. in Public Administration and Policy.

Johnathan Haub served as an Assistant United States Attorney in Portland, Oregon, beginning his federal service in 1989. He had over 40 years experience in law enforcement, corrections, and prosecution fields. He was assigned to the Violent Crimes Section of the Criminal Division, Portland Office. He also served in the Organized Crime Drug Enforcement Task Force, and led the Treasury Financial Crimes Task Force, as well as the Human Trafficking Prosecutions Task Force in the District of Oregon.

In October 2010, John completed a two year assignment as the Resident Legal Advisor at the American Embassy, Podgorica, Montenegro, where he served as advisor to the Office of the Special Prosecutor for Organized Crime, Corruption, Terrorism, and War Crimes. In November, 2010, he received the Montenegro Order of the Flag, Second Degree from President Filip Vujanovic for his service to Montenegro in contributing to improvements in the rule of law.

While previously assigned to the Organized Crime Drug Enforcement Task Force from 1989 to 1998, he co-authored "A Case Agent's Guide to Search & Seizure in the Ninth Circuit", a 400-page treatise on all aspects of search and seizure law in a federal context. He has prosecuted many international drug trafficking conspiracies, complex financial crimes, and was experienced in international legal extradition cases.

Prior to beginning federal service in 1989, he was a prison guard, Army Military Police officer, Clackamas County, Oregon, Deputy Sheriff, District Attorney's Investigator, and Deputy District Attorney. As a state court prosecutor for more than 13 years, he lectured on child sexual abuse prosecutions, forensic evidence in homicide cases, techniques of persuasion, and interrogation and trial techniques. He tried over 20 murder cases while a state court prosecutor, including two death penalty cases.


In 1995, while on active duty in Haiti, he served as a regional chief of a team of Army lawyers who mentored and trained justices of the peace, investigating magistrates and prosecutors in a program called "Conseiller Technique." Thereafter, at the request of his commanding general, he returned to Haiti as a Department of Justice Prosecutor and chaired the Felony Trial Project at the US Embassy in Port-au-Prince. This was a program to expedite the trial of murder cases and improve the confidence and security of Haitian judicial officers. While in Haiti, he led the first class of Haitian Judicial Officials to complete a two-week course on basic criminal investigation at the FBI Academy, in Quantico, Virginia.

Again called to active duty in 1997, he served in Bosnia and Hercegovina as Assistant Chief of Staff at the Office of the High Representative, (OHR) in Sarajevo, as a civil-military cooperation (CIMIC) officer.

He has lectured at a DEA Judicial Training Seminar in St. Petersburg, Russia, as well as at the Naval Postgraduate School in Monterey, California on Civil Military Operations, Humanitarian operations, Peace-keeping, Refugee Operations, and counter-terrorism cases. He also lectured to NGOs and military officers on Civil-Military Operations and the Rule of Law, and related subjects in Bucharest and Brasov, Romania, Tegucigalpa, Honduras, Kinshasha, Democratic Republic of the Congo, and Luanda, Angola.

He became Airborne qualified, and had three military specialties: Military Police, Psychological Operations, and Civil Affairs. He graduated from the British Psychological Operations course in Ashford, Kent, in 1989. He commanded a Psychological Operations Company and a Civil Affairs Brigade for three years as a Major. In 2001, as a Colonel, he commanded the 364th Civil Affairs Brigade in Portland, Oregon, until his mandatory retirement from the Army in 2002.

He graduated from the University of Iowa in 1970 with a Bachelor of Science Degree in sociology and criminology. He received his Juris Doctor degree from Lewis and Clark College's Northwestern School of Law in 1976.
